2009 Nominated or Renewed Stallions and Mares receive a 10% share of the Futurity purse.

For the first time in 2009 we are allowing you to Nominate your great mares and encouraging you to promote the wonderful genetic traits that many of our KMSHA/SMHA mares possess.

If you are ONLY Nominating or Renewing your mares and stallions this year we wish to thank you for helping to promote the future of this wonderful breed and registry, if you are planning to show than please read the new 2009 Entry Fees and Nominating Information below.

As before only the current Nominated and Renewed Stallions and Mares will be eligible for the 10% share of their Offspring's Futurity Purse.

HOW CAN MY HORSE BE A PART OF THE 2009 FUTURITY?

If you have offspring (colt, filly or gelding) of a nominated KMSHA/SMHA Futurity stallion or mare listed on page 21 then your horse (offspring) is eligible to show in the 2009 Futurity once entered in the proper age division class.

- Any colt or mare, 2 years old and older that wishes to show under saddle may be Nominated and Entered in the Futurity for \$100
- ALL geldings must have a nominated or renewed sire or dam to show under saddle
- 5 year old and older Stallions may be Nominated and Entered into the \$1,000 Stallion Stakes :
 - *\$150 for first time Nominees in 2009
 - *\$100 Renewal fee for all Stallions that were Nominated previously

The 2009 Futurity will offer KMSHA and SMHA classes for Weanlings, Yearlings, 2-year olds, 3-year olds, and 4-year old and older. There will be two KMSHA/SMHA 5 year old and older Stallion Stakes classes.

The KMSHA and SMHA Weanling classes will split into filly and colt classes if more than 12 horses are entered in these divisions.

Two-year olds and older will be presented first under saddle and then conformation (except 2-year olds showing conformation class only). Grooms may enter the ring after all horses back up in the lineup!

Exhibitors who will be competing in the 2009 Futurity must submit their Nominations for Sires and Dams and Entries for offspring by the September 30, final deadline.

The 2009 Futurity will be held in conjunction with the KMSHA/SMHA International Grand Championship on Thursday, October 8 at 9 a.m. For more information contact the KMSHA office at 502-863-3545.
